**Explanation of Responses:**

- The reporting person received 2,300 restricted stock units on February 23, 2006. The restricted stock units vest ratably over a three-year period. On February 25, 2008, 766 restricted stock units vested.
- The restricted stock units do not expire.
- The reporting person received 4,600 restricted stock units on February 24, 2005. The restricted stock units vest ratably over a three-year period. On February 25, 2008, 1,532 restricted stock units vested.
